Fund guidelines

About the Fund

The Evening Standard Dispossessed Fund was set up in 2010 to help grassroots charities tackling poverty, inequality and exclusion across the capital. The Fund is a restricted fund of The London Community Foundation.

Each year, the Evening Standard Dispossessed Fund focuses on a particular theme. This has previously included supporting young people out of gang activity, using football coaching as an agent for social change, funding communities through the Estates programme and supporting organisations repurposing surplus food to provide for those facing food insecurity in London. This is now the third round of Save London Lives, with the first round running July 2018 to September 2018, providing support to organisations working across Trauma, School or Family support. The second round ran from November 2018 to February 2019 and this is now the third round, running from March 2019.

About The London Community Foundation

We believe in a strong and vibrant London, in which everyone has the chance to thrive, regardless of who they are or where they're from. We offer a lifeline to Londoners who are suffering multiple disadvantages including inequality, exclusion and discrimination. Our reach

We are an independent charity and one of over 1,700 community foundations worldwide. Today, thanks to the generosity of our supporters, we invest around £6 million annually, giving out around 1,000 grants every year to charitable projects across the capital. We support a wide range of charities and community groups across London, enabling a number of different organisations and projects to achieve impact. We specialise in finding and funding smaller organisations that do not attract mass public support, or who are at an early stage in their development.

Why L&Q Foundation support this fund

The L&Q Foundation (part of London & Quadrant Housing Trust) develops and funds social interventions that improve people's chances in life and create opportunities in our communities. It is thanks to a generous donation from the Foundation that a third round of funding is now available through the ESDF Save London Lives fund.

The Foundation is divided into three strategic pillars, Independent Lives, Successful Places and the L&Q Academy and with around 100,000 properties in and around London. They are committed to investing in activities that increase opportunity and aspiration for both individuals and the wider communities they create and manage.

Housing associations have a tradition of supporting grass roots community engagement and L&Q Foundation will continue to do this, investing where they are likely to have an impact and make a real difference to where people live.

Aims, Themes and Criteria

Aim

The aim of this fund is to build a better and more robust community response to youth violence in London by increasing the impact and resilience of organisations working to reduce violence among young people across London.

The fund will encourage and support locally based solutions that are developed and delivered by a range of organisations, working together in areas across London.

To achieve this, across three years this fund will provide:

- grants of up to £30,000 (up to £10,000 per year) for core costs for organisations with demonstrable experience and impact of working to reduce violence among young people in London
- a series of free capacity building, training, work place visits and pro bono support so that community organisations receive business support and access to networking pan-London.

Through this approach, the fund aims to:

- increase the resilience and impact of organisations working to reduce youth violence and crime in London
- encourage increased community engagement and ownership of the issues and solutions relating to youth violence in London
- encourage collaboration, connectedness and sharing best practice among organisations responding to youth violence across London and into the wider Youth Violence response in London.

Themes

Through this fund we will provide core grant funding, capacity support and networking opportunities to organisations in London who are responding to youth violence under at least one of the following themes:

- Trauma
- School
- Family
- Employment & Enterprise

Criteria

In addition to meeting the aims and themes of the programme, organisations will also need to demonstrate evidence of the following:

- Experience/track record of working in the field of youth violence
- Experience/track record of collaboration and understanding of other organisations working in the local and thematic area
- Commitment to collaboration and partnership working including a commitment to attend engagement events across London
- Local presence or engagement

Initiatives that this fund will support:

This fund is intended to provide core funding to support organisations working to reduce youth violence under one of the themes of trauma support, family support, in school support or employment support.

Rather than providing project specific grants, organisations are encouraged to apply for core funding towards their organisational expenses and core operating costs, which could include staff training, salaries, rent, systems improvement, therapeutic support or clinical supervision for front line staff.

Funding Available

- Grants of up to £30,000 (maximum £10,000 per year) are available over three years
- Funding will contribute towards core costs and a level of capital funding (such as IT equipment, capped at 25% of any grant).

You can apply for core costs including insurance, staff costs and salaries, organisational marketing and promotion, evaluation and monitoring systems, rent etc.

You can also include costs that will help to build the capacity and/or sustainability of your organisation – for example, training, or a piece of software that would enable you to better track your beneficiary outcomes in relation to this project.

As part of this programme, organisations will be expected to attend networking events. This is to ensure organisations are connected and collaborating towards an overall shared goal of reducing youth violence across London.

Organisations will also have the opportunity to benefit from pro bono support and training from our corporate partners.

If organisations applied under Rounds 1 and/or 2 of Save London Lives but were not successful, you are eligible to apply again to this Round 3.

Priorities for the fund

As this is the third round of funding under Save London Lives, we are looking to support projects that are additional to and do not duplicate initiatives already supported through the Save London Lives programme. We will therefore look to achieve a good geographic spread of projects across London, with priority in areas that received lower levels of support in Rounds 1 and 2.

We may therefore prioritise applications from organisations operating in the following boroughs:

<u>Organisations supported in Rounds 1 and 2</u> can be found here. Please note that organisations already in receipt of a grant through Rounds 1 and 2 are not eligible and will not be supported through Round 3.

Organisations will need to demonstrate that their work aligns with at least one of the following outcomes:

Increasing opportunity and aspiration

Young people are better equipped with the skills, knowledge and attitudes to join the work force or go into further education

Increased community engagement

Increased place-based activities and levels of participation from vulnerable young people.

Improved levels of personal wellbeing

Better social outcomes for people living in lower income communities.

Organisations with income of less than £500,000 may be prioritised.

Who can apply?

Constituted community groups, registered charities, companies limited by guarantee, social enterprises or Community Interest Companies Ltd. By guarantee are all eligible to apply to the fund.

Applicants will need to have the following in place in order to apply:

- a minimum of 3 un-related Management Committee members
- a governing document (e.g. a constitution or set of rules)
- a bank account in the name of the group, with at least 2 unrelated signatories
- a record of income and expenditure or set of accounts (or bank statement if you are a new group)
- an up to date 'safeguarding policy' for children and young people under 18 and/or for vulnerable adults
- the relevant insurance in place, including public liability where required (you can include this in your budget as necessary)

What cannot be funded through this programme?

- Applicants already in receipt of a grant through Rounds 1 or 2 of Save London Lives
- Applications from Local Authorities or any activity that is a statutory requirement (e.g. school curriculum)
- Any party-political activity
- Purely commercial ventures (for profit)
- CICs limited by shares
- Spending that has already taken place (i.e. retrospective funding)
- Organisations whose current liabilities have exceeded their current assets at the last two balance sheet dates
- Organisations where trustees are paid, unless evidence of approval is provided from the Charity Commission and this arrangement is referenced in the governing document
- Organisations in receipt of Directors/Trustees Loans
- Individuals or projects run by individuals as opposed to an organisation
- Activities where people are excluded on religious grounds, ethnicity, gender, sexuality,

faith etc.

- Activity that is the responsibility of Statutory organisations
- Applications from organisations with overdue or incomplete monitoring on a previous grant from The London Community Foundation from any of its programmes. If you know you have outstanding monitoring on a previous grant, please contact The London Community Foundation to resolve this.

Closing date for applications

The closing date for applications is 1st May 2019

Decisions are due to be announced by 21st June 2019.

How to apply

Applications for the Fund are submitted through an online application form including all supporting documents.

Please read the instructions carefully, tick to say you agree and have understood, enter your e-mail address and click on the "Send e-mail and continue".

Once you have done this you will be sent an e-mail with a link to your unique online application form. You should receive the email within a couple of minutes (please check your spam or junk folder). If you do not receive an email it may be that you have not entered your email correctly – please check the address before submitting.

To begin your application, please click on the link within the email that you have received from us. There are help notes available as you go through the online application form and you can save your application at any point and come back to it to complete it at any time before the closing date. The help notes are also available as a separate document via the website. You must remember to press the save button before closing down your application.

At the end of the application you will be asked to upload the following supporting documents:

- Your governing document (e.g. your constitution or memorandum and articles)
- Annual accounts or record of income and expenditure (or bank statement if a new group)
- For CICs- A full set of accounts including your income and expenditure and balance sheet with debtors and creditors, and budget for current/following year.
- Up to date Safeguarding Policy
- If you are NOT a charity, Community Interest Company or Company Ltd. By Guarantee, please provide names and addresses of at least 3 unrelated management committee members/trustees
- Quotes for any capital items or costs for installation (you do not need to send quotes for small equipment items e.g. computer equipment)

NB: We need all these documents when you submit your proposal in order to fully consider your application. If all these documents are not submitted, your application can not be considered.

Once you get to the end of the application form there will be a 'Submit' button. Please note

the submit button is after you have verified your budget. Once you press this it will automatically send your application through to the Foundation and this will be accepted as a completed application. Please do make sure you submit everything before the deadline.

Please contact us if you would like help or are having any difficulties in submitting your form or uploading the documents; you can call The London Community Foundation on 020 7582 5117 for support.

Some top tips for top applications

- Draft your responses before completing the online form
- Regularly save your online form when in progress
- Make sure that every question has been answered in full
- Use the application help notes to make sure you answer all questions fully
- Ensure your budget section has a clear breakdown of all the costs associated with your application
- Ask somebody to read through the application before you finalise it preferably someone who knows nothing about the project. This is a great way to pick up on any mistakes or lack of information and rectify it before submitting.

What happens next?

Applications which best fit the fund aims and themes will be shortlisted. Shortlisted applicants may then be telephoned by a Programme Manager from The London Community Foundation to gather any additional information needed about your project and/or organisation.

Shortlisted applications will be presented to a Fund Panel which will make recommendations on grant awards. Successful and unsuccessful applicants will be notified following the panel decisions on or around 21st June 2019.

If you are successful in securing funding, L&Q neighbourhood staff may wish to promote your project in key boroughs.

Timetable for spending the grant

Applicants can submit a request for grant funding over a period of three years. Grant award decisions for the full three-year period will be made and awarded in 2019. At the end of each year, applicants will be required to submit end of year monitoring which will be reviewed and if all is in order, future payments will be made. Monitoring dates will be set out in your offer letter, if successful. Grants cannot cover activities taking place before any grant is awarded – please refer to the dates above when planning your project start date.

Living Wage Friendly Funder

The London Community Foundation is now a Living Wage Friendly Funder. This scheme, run by the Living Wage Foundation means that The London Community Foundation will actively encourage and support applications from organisations willing to pay staff the Living Wage (currently $\pounds 10.55$ in London), or higher. The London Community Foundation has been a Living Wage Employer for a number of years and have decided to become a Friendly Funder in recognition of the hard work and commitment that the employees of the organisations we fund undertake.

These projects and organisations are a vital pillar of London's vibrant communities. Without the

dedication and commitment of their employees, London would not be the great city it is. We believe passionately that, where possible, organisations should pay their staff at a level that they can live on, to ensure that the fantastic work or the Capital's community groups, charities and social enterprises can continue into the future. We hope that, eventually, all funders will sign up to the scheme and together we can work towards ending low pay in the community and voluntary sector in the UK.

While we are very proud of supporting the Living Wage, we do not want this to stop anyone applying for funding. If, for any reason, paying this level will not be possible for your organisation, please call and discuss the situation with us before making an application.

What does this mean for applicants?

If you are applying for funding any staff costs (this could include existing staff members, sessional workers, part time or full time posts, freelance workers) you should budget these at the Living Wage or above. We are sensitive to circumstances where organisations feel that taking up the Living Wage could cause difficulties. In these instances, we suggest you call us on 020 7582 5117 to discuss your options before applying.

This does not require employers to pay the Living Wage to apprentices or interns although we recommend it as best practice for employers who can afford to do so. Many accredited employers have chosen to extend the requirement to apprentices and interns.

Currently the Living Wage is £10.55 in London.

What is the Living Wage?

The Living Wage is an hourly rate which is set independently and updated in November each year by The Living Wage Foundation. It is calculated according the basic cost of living in the UK. The current London Living Wage is £10.55. Please note this is different to the national living wage announced in the government's 2015 budget.

How will paying the Living Wage affect posts?

Paying at least the living wage applies to all posts, including existing roles, new roles, sessional and freelance workers (it does not need to apply to apprentices but we encourage groups to pay a Living Wage) that are funded by one of our grants. If The London Community Foundation is part-funding posts, we will pay at least the Living Wage on the part we are funding. Further to this, if you feel you are unable to afford to pay a worker at Living Wage please do not hesitate to contact us to discuss the matter further.

Do we have to pay The Living Wage across the organisation or be an accredited Living Wage employer to apply?

You do not have to be an accredited Living Wage employer to apply for funding or pay a Living Wage to all of your staff to apply for this funding. We strongly encourage you to consider Living Wage Accreditation if you are in a position to do so. Monitoring and evaluation

Groups in receipt of a grant will be required to complete an online monitoring form at the end of each year, outlining how the grant was spent and highlighting the benefits for beneficiaries, participants and the wider community. You will be provided with the link to the online form if you are awarded a grant and must return your monitoring form within four weeks of the end of each year of your project ending, by the deadline date. You will therefore need to submit an end of 1st year, end of 2nd year and end of final 3rd year monitoring form.

Monitoring and evaluating the projects funded by our grants enables your group and us to better understand the impact of the grant. For this programme, it is important for you to be able to measure the difference made by the grant. The London Community Foundation may wish to conduct monitoring and evaluation visits to funded groups.
